

Junior Hound Judging Program Guidelines, Protocol, Score Sheets



The MFHA Junior Pack Hound Judging Program teaches juniors about hound breed standards in a fun and educational way. Participants will practice decision making and reasoning skills while actively assessing foxhounds. Let's get our juniors more involved and empower their foxhunting and hound knowledge.

Junior Judges will:

- Learn about the standards of the Foxhound breeds
- Recognize good conformation and the basis for longstanding soundness
- · Learn to evaluate and compare three different live hounds
- · Learn proper terms when describing hound conformation
- · Learn to make and defend decisions
- Learn to recognize quality in breed, condition of the animal, and willingness of the hound

What you need to host a Junior Hound Judging Program:

- Hound judging event, formal as a Hound or Puppy Show or informal like a kennel tour or Pony Club visit
- Three distinct hounds per class
- · Three ways to distinguish hounds
- Juniors Judging Score sheets (attached)

Rules and Procedures for Junior Judging Class:

- Each class will be based on hound availability. There will be three dogs OR three bitches of the same breed in each junior judging class.
- Each hound will be defined by a number, ribbon color, or other distinguishing charac teristic for identification purposes.
- Tip: Have a markedly superior hound and two other hounds with distinct issues. So as to allow the children to recognize and understand the different correct and incorrect points.
- The class will be conducted just as any other hound class, there will be movement as a group as well as for each individual hound.
- Prior to the start of judging, the huntsman will bring out a hound with desirable conformation points and show the juniors the exact points they are to be judging that day. The hound used for the demonstration may not be included in the junior judging class.
- The junior judges will view each hound, they are permitted to walk around and observe and take notes on each hound while it stands. * No touching or physical contact with hounds is permit ted by junior judges. This will be enforced and junior judges will be excused from the ring should contact be made. This is to protect participants and animals.
- Once each junior has made observations, taken notes and made placements, they may step to the side to complete the final rankings. They will then formally turn in their class rankings to the class official.
- Junior judges may keep notes he/she took on each hound, however they may not ask for the scorecards back after they are turned in. No exceptions.
- Not all judging contests are the same. The class may require written explanations or oral reasons to be given in different circumstances. The possible explanations and their format will be chosen at the time of the class by the officials.

Junior Judge Decision Making: Tips

Comparing and deciding differences in hounds can be challenging.

To prepare for a judging class, each contestant has several opportunities to learn and practice making the same decisions that an official hound show judge would make at a show. The junior judge will look at each of the three hounds to determine which animal best matches the breed standards. The "perfect" hound is rare, the junior judge is tasked with recognizing faults and differences between the animals.

The following steps are the process for deciding between three hounds:

- 1. Observe and watch each hound carefully, look for good points, get an overall impression of each animal and its personality.
- 2. Go through your list of criteria and check yes or no for each conformation point.
- 3. Tally the yes column and the no column for each hound.
- 4. A hound with all good conformation boxes checked is your 1st place hound
- 5. The hound with the most in correct conformation points checked is your third place hound.
- 6. If you think you have a tie, look again and reconsider your marks. There is a first place, second place, and third place.
- 7. Don't be influenced by others! Learn to trust your own judgement, everyone is learning and the official judgement will be made by experienced judges.






